Non-personal identification information

Recite App w/Google Drive

Google drive experience within the Recite App is completely optional and is added as a bonus feature. Users may sign in to their Google Drive to share Recite Activities and completed work. Recite App does not store google drive credentials. Authentication with the google drive is performed by Google only.

COPPA Compliance

Recite Learning’s product offerings are in compliance with the Children's Online Privacy Protection Act (COPPA). Our products do not hold or persist any student data. We only store student email addresses to further ensure and protect Recite Learning’s licensing rights.

FERPA Compliance
